WHAT TO EXPECT

Franklin County's Juneteenth Celebration will be Saturday, June 17, from 11am to 2pm at NETwork Ministries Garden, 10 Redwood St., Chambersburg, PA.

The family-friendly event features live entertainment, games and activities for the kids, a K-12 book giveaway, a silent auction, prizes, food for purchase, and non-profit and business vendors.

LARGE DIVERSE CROWDS

The Juneteenth Celebration hosts more than 200 people who attend from all over Franklin County and beyond.

FREE ADMISSION

Juneteenth is free and open to the entire community. Everyone is welcome to attend!

KIDS' ACTIVITIES

Children will enjoy a Bouncy House, a Double Dutch Competition, Face-Painting, Hula-Hoops, Dominos, the popular K-12 Book Giveaway, and more!

FREE ENTERTAINMENT

Music, Dancing, Urban Poetry, and a fun Juneteenth photo booth are just a few of the offerings announced so far!

FOOD VENDORS

Yummy food and treats will be available for purchase throughout the event.

VENDORS + SWAG

Throughout the celebration grounds you will find vendors promoting their businesses and organizations. They will also be giving out raffle tickets for prize drawings.

SMOKE-FREE

The Juneteenth Celebration by Racial Reconciliation of Franklin County is a smoke-free event and does not accept sponsorships, vendor fees or any other funding from tobacco companies, including cigar, e-cigarette, or vape stores.

VENDOR FAQs

If you are interested in applying to become a vendor at Juneteenth, please take a moment to read through the following frequently asked questions.

WHEN/WHERE IS THE JUNETEENTH FREEDOM CELEBRATION IN FRANKLIN COUNTY?

Saturday, June 17, from 11am to 2pm at venue host NETwork Ministries Garden, 10 Redwood Street in Chambersburg, PA. The celebration will be held outdoors. In the event of rain, the celebration will be moved indoors at the venue.

HOW WILL I KNOW IF MY APPLICATION IS ACCEPTED?

Vendor applicants will receive an email notification following review from Racial Reconciliation of Franklin County stating whether your application was accepted or rejected. In some instances, we may be limited in who we can accept as a vendor (i.e., exclusivity contracts) and/or we may limit vendors based on similar products. Reserve your spot now! There are only 10 vendor tables available! The earlier you register, the better chance you have of being approved. Payments will be returned to any rejected applicants.



WHEN CAN I SET VP? All Juneteenth setup begins at

8:30am and ends at 10:30am. All vendors must check in by 9:30am. No late arrivals or set-ups will be allowed, and no fees/charges will be refunded to vendors who fail to arrive within the setup window or at all. Vendors will be directed to an area to unload their items. then move their vehicle to the designated parking area before setting up. Vendors may not park anywhere else. Information for the designated parking area will be provided closer to the event. NOTE: Vendors who wish to drop off set up items early, may bring them to NETwork Ministries, 10 Redwood St., to be stored indoors overnight on Friday, June 16, anytime between 12-3pm.

WHERE DO I PARK?

All parking information will be emailed to vendors in advance.

WHAT ARE THE GVIDELINES FOR TABLES, CHAIRS, AND CANOPIES?

One vendor table (card table size) and two chairs per table are provided. Each vendor space is 6x6 so all of your supplies must fit in your space. A small pop-up canopy may be brought. Canopies may not be larger than 6x6, in accordance with Borough permit requirements and venue space limitations. If you bring a canopy, please make sure your canopy is weighted down or staked.

IS THERE ELECTRICITY? No electricity is available.

WHEN IS TEARDOWN?

Teardown will begin at 2pm, at which time vendors may bring their vehicles back onto the event grounds. Please note that vehicles will not be permitted onto the grounds until organizers deem it safe for patrons. Vendors must teardown their spot before getting their vehicle. Vendors are responsible for the trash or refuse in the immediate vicinity, in their vendor location or associated with their vendor activities. Any vendor not in compliance will be subject to an additional \$50 clean-up fee.

VENDOR RULES & REGULATIONS

Vendors agree to the following rules and are responsible for informing participants and/or employees of these rules.

INCLUSION:

The Juneteenth Celebration by Racial Reconciliation of Franklin County welcomes the participation of all people regardless of age, creed, gender, gender identity, HIV status, national origin, physical or mental development ability, race, religion, or sexual orientation and asks all participating organizations to also engage in non-discriminatory actions. Participants are to show respect for all genders, ages, races, cultures, faiths, and sexual orientations and are to be aware that children will attend the celebration.

VENDOR RAFFLE PRIZE:

Each vendor must provide one giveaway of some kind (a free service or an item of merchandise). Vendors will give each visitor to your vendor table a ticket (provided by Racial Reconciliation). This item will be raffled off toward the end of the event.

VENDOR CANCELLATION POLICY:

Advanced notification of vendor cancellations are considered for reimbursement on a case-by-case basis. No fees or charges will be refunded to vendors who fail to arrive prior to the setup deadline or do not appear at the event at all (no shows).

EVENT CANCELLATION / EARLY CLOSURE POLICY:

Racial Reconciliation of Franklin County reserves the right to cancel an event due to low enrollment or other circumstances which would make the event non-viable. If the event is cancelled, registrants will be offered a full refund. Should circumstances arise that result in the postponement of an event, registrants will have the option to either receive a full refund or transfer registration to the same event at the new or future date. No refunds will be made available in the case of an early closure of the event due to inclement weather and/or emergency.

RESPECT FOR VENUE HOST GROUNDS / PROPERTY:

NETwork Ministries is an urban youth ministry for children and teens in Chambersburg, Pennsylvania. Since 1993, they have been committed to sharing in the love of Christ with those who are most vulnerable in our community. For Juneteenth 2023 NETwork Ministries is partnering with Racial Reconciliation of Franklin County by providing space for the event. It is understood that all vendors will respect the property while transporting, setting up, and removing their wares and equipment.
